The Idaho Community Foundation Awards Nearly \$214,000

Idaho – The Idaho Community Foundation (ICF) is excited to announce the recipients of the 2024 Forever Idaho South Central grants. These grants, funded by the generosity of charitable and community-minded Idaho residents, provide support for the operational needs of organizations serving South Central Idaho. This year, a total of \$213,750 has been awarded to 34 organizations in the region.

The Forever Idaho program allows grantees to use the funds flexibly, addressing the most pressing needs within their organizations and communities.

The applications for these grants were reviewed and selected by ICF's Regional Council, a volunteer group of local citizens and community leaders who thoughtfully assess each application and make granting recommendations. ICF strongly believes in local decision-making, ensuring that funding decisions reflect the unique needs and priorities of the communities being served.
